I. 10th Anniversary of IPDL

1. About IPDL


"IPDL" stands for the Industrial Property Digital Library, offering a variety of services that enable its users to search and access comprehensive IP related information via the Internet. With increasing importance of IP information and growing popularity of Internet, the service of IPDL was initiated in March 1999 with the aim of making IP information available to the public free-of-charge anywhere and anytime. Since its much-anticipated launch, IPDL has prevailed throughout the world and marked its 10th anniversary this year.

About the same time, the European Patent Office (EPO) and the United States Patent and Trademark Office (USPTO) have also commenced their web services equivalent to that of the JPO's IPDL between 1998 and 1999. This clearly indicates that the launch of IPDL undoubtedly and practically responded to the changes and needs of the times.

2. Initial services

In the initial service of IPDL, search services using document numbers and classifications for publications of patent, utility model, design, and trademark were available, and also legal status information for filing, registration and appeal were provided. The total access to the service of IPDL in 1999 was 12.7 million (increased up to 95 million in 2008). The following section explains services which have been developed, improved, or added since its beginning, as well as trends in access to and searches on IPDL.

3. Developments and improvements


Every year since its beginning to the present, much effort has been devoted to develop and improve services on IPDL. Some of the major developments and improvements and the increase in the number of accesses are introduced below.

- In March 2000, search service for figure trademarks, information service for Patent Abstract of Japan (PAJ), and machine translation service of unexamined patent applications were added in the English version of IPDL.
- In March 2001, FI/F term search service and Patent Map Guidance (PMGS) service were established.
- In 2002, three years from its beginning of the service, the total amount of documents data accumulated in IPDL reached 48 million and the number of accesses to IPDL rose up to over 40 million.
- In March 2004, design gazette DB service began.

With the aim of further upgrades and enhancements after its operation being transferred to INPIT, the Trilateral List of Identification of Goods and Services, which includes English names of services and goods agreed among the Trilateral Offices, was added in the service of "List of Service and Goods" in March 2008.

Furthermore, various legal status information, such as information on filing, publication, examination, etc. provided on the English version of IPDL have been integrated, that is to say, "LEGAL STATUS" bottom was created to enable all the legal information of a certain application to be displayed simultaneously as a list.

II. Internet Trademark Publications from January 2010

1. About the "Official Publication via the Internet"

Since significant advances in information and communication technologies have impressively changed the style of information dissemination, the Internet and other means based on network technology have become the most popular ones.

In order to make most use of such a rapid development in information dissemination technology and to disseminate industrial property information as broadly and promptly as possible, it was a major issue to adopt the most versatile media and the most convenient way for publication in a flexible manner.

Taking advantage of the new Law, the JPO developed the website called the "Official Publication via the Internet" (see Screenshot.2 for an image of the top page) and started the "Official Publication via the Internet for Registered Utility Model Applications" and "Official Publication via the Internet for Registered Design Applications" in January 2006 and January 2007, respectively. The JPO has also just started "Official Publication via the Internet for Registered Trademark Applications and Unexamined/International Trademark Applications" from January 2010.

III. The Trilateral Offices to Start PCT-PPH

The Trilateral Offices reached agreement to begin a pilot program in the Patent Prosecution Highway (PPH) framework utilizing PCT work products (international search reports, written opinions, and international preliminary examination reports) of a Trilateral Office.


Under the existing PPH programs, an applicant receiving a determination from an office of first filing that claims in an application are allowable may request that the corresponding application filed at a second office be advanced out of turn for examination as to those allowable claims (see the diagram below).

Until now, the PPH programs have been limited to cross filings of national applications (dotted arrows in orange). This new agreement among the Trilateral Offices greatly expands the potential of the PPH programs by providing the re-use of positive results from PCT work products of a Trilateral Office (dotted arrows in blue).

Under the new pilot, the applicant can now:

- make requests for PPH at an earlier timing, based upon the international phase work without awaiting the work results of the national/regional phase, and
- make full use of PCT work products including its English translations


